## **MEETING ROUNDUP**

Talented writer **Lisa Brackmann** discussed her latest book, *Go-Between*. A followup to her 2012 thriller *Getaway*, it deals with the intersection of for-profit prisons, big-money politics, shady non-profits and the war on drugs. Her interest in our "prison/industrial complex" – in particular, private, for-profit prisons – triggered the book.

A definite pantser (one who writes by the seat of her pants, as opposed to outlining a book first), Lisa doesn't usually know the ending when she begins writing. "When pantsing works," she says, "it can lead to a more organic story." She advocates treating writing like a job and keeping a regular schedule. "Show up whether you want to or not." But, she acknowledges, sometimes you do need to take a break.

Her first books required "tons of rewriting," but by the third book she had figured out the process. She writes slowly – aiming for 500 words a day – and fiddles with language as she goes, so she doesn't require major rewrites with her editor. She is a fan of well-crafted prose, which she demonstrated when she read a scene from Go-Between.

She bemoaned the fact that eBooks have depressed the industry, noting that often people pay more for a cup of coffee than they do an eBook, and pointed out the fact that it takes just as long to write a midlist book as it does a bestseller.

Lisa also writes the series featuring Ellie McEnroe, an Iraq War vet living in Beijing. The series debuted in 2010 with "Rock Paper Tiger."
