The next meeting will be at 2:00 on Sunday, 25 February. Our guest speaker will be Shannon Laren. Sgt. Laren of the Los Angeles County Sheriff's Homicide Bureau focuses on the details of an investigation, and believes nothing spoils a story quicker than when a writer describes an unrealistic situation and tries to pass it off as real. It's only believable if it's possible. Laren has spent the past 14 years in Homicide finding the evidence to prove the truth by focusing on the details of the crime. Now after 32 years in law enforcement working for the LASD, he's scheduled to retire at midnight on Feb. 27, 2018.

He has a long history in law enforcement and even longer history with firearms. He was introduced to firearms at the age of 12, began hunting at 16, and entered law enforcement at 18 working as an undercover security officer at Kmart, Target and Ralphs, arresting shoplifters and employees who stole from the companies.

At 21, Laren joined LASD and spent the first three years as a Custody Deputy at Men's Central Jail in downtown Los Angeles. He served the next eight years as a Patrol Deputy, Special Projects Deputy and Field Training Officer, and then four years as Station Detective. Laren spent the majority of his patrol time in South Central Los Angeles. After 15 years as a Deputy, he was promoted to Sergeant. He worked for three years in East Los Angeles as a Patrol and Detective Supervisor, and then reassigned to Homicide in 2003 as Investigator. In the Homicide Bureau, Laren has investigated hundreds of murders, officer involved shootings, suicides, accidental deaths, industrial accidents which led to death, child deaths, natural deaths and suspicious deaths. He has authored hundreds of search warrants, arrest warrants and court orders, as well as testified as an arresting and investigating officer, and expert in the fields of narcotics and firearms in the Los Angeles Superior and Juvenile Courts.

During his years as an Investigator, Laren has convicted many killers who are now serving a variety of sentences in state prison, including life, life without the

possibility of parole and death. He's been trained to investigate homicides, officer involved shootings, gang behaviors, assaults, firearms, thefts, frauds, sexual assaults, possessions, transportations, sales and manufacturing of narcotics, arson, explosives and domestic and international terrorism. He has been involved in riots in jail and on the street, involved in multiple vehicle and foot pursuits, fights, vehicle accidents and several shootings. He has witnessed people being shot, stabbed, beaten and run over, and watched several of them take their last breaths. He has been stabbed, shot at and beaten on a few occasions.

Laren also served five years in an Infantry Battalion in the United States Marine Corps Reserves from 1986 to 1991. During his last year, he was activated and deployed to South East Asia during the First Gulf War as a squad leader in a rifle company. He received an honorable discharge at the rank of Sergeant.

## MEETING ROUNDUP

OC Sisters in Crime kicked off the new year with a fantastic Forensics Fest guest speaker, Wes Albers. A 28-year veteran with the San Diego Police Department, Wes has covered almost every inch of San Diego, as a uniformed officer, a detective, and a liaison with various agencies. For our meeting, he was happy to share his experience at crisis negotiations.

Crisis negotiations cover several kinds of crisis: a suicidal person, a family member with hostages, and a public situation (ie, bank robbery). Each case must be handled differently, and negotiators have a difficult job, assessing and delivering what is needed to end things peacefully.

Wes kept the audience enrapt during his talk, as we all took furious notes about how negotiations work. Although most of us realized that it's not the way most movies portray it, with a single hero working alone, there were still plenty of surprises.

We learned that:

Although San Diego is the second largest city in California (L.A. is first), SDPD staffing is half the size of Dallas.

Integration of different agencies is important. A negotiations team includes mental and physical health professionals, as well as local law enforcement and federal agents. There are typically over 50 people on most emergency negotiations teams, all of whom have many hours of training.

The most important thing in negotiating is to get the person talking. If they do not have a cell phone, the team has an encased phone on a line to throw through the window. If that isn't possible, they have a bullhorn. The negotiations team would rather talk the person out peacefully, even if it takes hours.

Individual officers can make decisions without awaiting orders if they see the situation escalate. If an officer witnesses the person pointing a gun at one of the

hostages and the officer is able to stop them, they do not have to be told to “take the shot.”

SWAT is often deployed with the negotiations team; however, they typically do not get involved in the decision-making unless someone has been killed.

Friends and family members can be brought in to help, but they are not allowed to speak directly to the person. The team will have them record a message that they can control.

A meticulous record of events is kept, both by a scribe recording the timeline of calls, names, threats, etc. and a whiteboard person who keeps track of all the notes during the event.

Every mission is debriefed immediately upon completion. If a death occurred during a mission, a psychologist is brought in.

The entire group was thrilled to have this information, delivered by a dynamic speaker like Wes. Whether you’re a writer or a reader, it was a fascinating look into how things really happen during a crisis. We can’t thank Wes Albers enough for spending his Sunday with us!
